Andy reviewed outcomes and feedback from NBWA's first virtual conference: Climate Change(d): Weathering Extremes *Together*.

The conference was a four-module event with three panelists each. Welcome/Keynote was provided by Jared Huffman, U.S. Representative for California's 2nd Congressional District.

Questions/Comments

Director Patterson: Can the 'Overhead and General Benefit Projects' title on the work plan be changed to 'Administrative Services'.

Director Bytof: Project A, B, and C of the work plan are outlined on the slides, do they need to specific on the work plan or are they intended to be determined as the work plan goes through the year?

Andy: Project A is really to have our deputy director participate and lead the Joint Technical committee, which hasn't been very active. Andy would like to talk to the board about carry over funds as well, and how best to use them for the region. The three-category structure provides flexibility for projects.

Director Meigs: Should there be a footnote in the work plan to provide clarity?

Director Patterson moved to accept the work plan, pending the above-mentioned changes. Director Fraites seconded. Unanimously accepted.

# 8. Board Information Exchange and Drought Updates

Director Gibson: MMWD has completed a number of studies over the years. They are now working with Jacobs Engineering designed to search for ways to increase water supply and making it more secure. They are also working with Sonoma Water for a similar study for better integration for the North Bay water system and One Water approach. He has asked Andy to look into having the team leader from Jacobs Engineering to give a presentation to the NBWA Board on their work.

They have completed some significant infrastructure improvements to allow them to take more water (within their contract limit).

Director Garcia: American Canyon has a lot of programs going on- Recycled water delivery is being renewed. One Water is up online for water monitoring. New construction takes into consideration water conservation to maintain resiliency.

Director Meigs: RVSD's newsletter recaps their lateral replacement grant program; since 2009 they have given their customers ~\$5M toward a lateral grant replacement program and have instituted low interest loans.

Director Carson: The stormwater programs in Marin, Sonoma, Napa, and Solano put on a new and redevelopment stormwater requirements workshop on April 12 which will be online soon. It was mainly for municipal staff, but there's another one being planned for the morning of June 7<sup>th</sup> that will be open to all the private development community to assist them to best implement stormwater requirements in their projects for the north bay. Anyone interested, contact him.

Director Patterson: Did you discuss stormwater in hilly communities, Benicia is right at the waterline?

Carson: The workshop is aimed at helping folks navigate how to implement stormwater permit compliance with their projects.

Director Fraites: Brought up Director Boorstein's message in the chat: Article in today's Marin Independent Journal on recycled water by Steve Moore, GM of RVSD <u>https://www.marinij.com/2022/05/05/marin-voice-new-water-ethic-should-include-drinking-recycled-wastewater/</u>

> He commented on the article touching on water ethic and drinking recycled wastewater. He thinks the article is worth a read for everyone.

> North Marin finally settled on some areas where they may be able to increase water supply. Including recycle water facility increases. There may be an opportunity to have another reservoir north of Novato; they're looking into it.

Director Clark: They are looking for a new General Manager. They are finishing their Secondary Treatment and Water Recycle expansion this year. Focusing on the Operational Control center and laboratory and will include a public education facility on the top floor. They are considering the education piece to be in a different area, due to building height requirements.
